## **Braking system: (CHECK All)**

fluid is clear, reservoir is full  pedal is firm  pads are less than half worn  all brake lights are working  master cylinder - no leaking fluid or corrosion  calipers and brake lines - no leaking  rotors have no cracks, discoloration or unusual wear

## **Suspension and steering systems: (CHECK All)**

wheel bearings are tight/no play  minimal play in steering linkage  lugs are tightened to specifications  bushings and pivot points show no signs of deterioration  wheels are not bent or cracked  shocks - no leaks  tires - adequate tread remains to complete the event  CV joints boots in place, no leakage

## **Drive train: (CHECK All)**

belts snug, no cracks or fraying  throttle return springs tight  coolant system – full, no leaks  battery – secured AND posts covered  wiring - properly harnessed  transmission- no leaks, shifts properly  no oil leaks

## **Driver safety: (CHECK Either/Or)**

DOT belts in good condition OR  5 or 6-point harness  optional fire extinguisher mounted securely  Convertibles – Driver fits under roll bar-windshield top  Convertibles - factory rollover protection OR  competition approved roll bar  (Check box and Initial) \_\_\_\_\_ that you will be wearing an SA2010 or newer Helmet  all loose objects removed from vehicle
