- [] [] **BRAKE LIGHTS:** both lights must be functional.
- [] [] **WINDSHIELD:** No cracks in any windows. good rubber seal.
- [] [] **MIRRORS:** at least one rearview mirror; securely mounted.
- [] [] **HELMETS:** Snell 2015 or Newer (SA or M) & have functional chin strap. Head & Neck Restraint is REQUIRED if using a 5 or 6 point harness.
- [] [] **PEDALS:** free return in good operating condition. Firm brake pedal.
- [] [] **SEAT BELTS:** metal to metal belts securely anchored. No rips, tears or fraying. (driver & passenger)
Check One: [] **Factory Seats/Belts** [] **Aftermarket Seats/Harnesses: Date/Exp Date on Aftermarket Harness Webbing:** _____
- [] [] **ROLL BAR:** required on all open cars without factory rollover protection or hard top.
- [] [] **BRAKE FLUID:** sufficient fluid (DOT 3 or 4 recommended). Should be bled prior to all track events. MUST have been changed within the last year. **Date Last Changed:** _____
- [] [] **BATTERY:** securely fastened. No acid leaks or corrosion. Check fuel lines under 914 tray.
- [] [] **FAN BELT:** fan & other belts tight, in good condition.
- [] [] **THROTTLE RETURN:** freely operating, with good springs. Check both springs on CIS cars.
- [] [] **FRONT SUSPENSION:** no excessive play in steering or suspension. Lower trailing arm to radius arm tight; axle & shock bolts tight; no leaks; ball joints in good condition; tie rods secure, axle boots & seals in good condition. 356 steering box - tight cover & coupling, no cracks; 900 series - tight steering rack.
- [] [] **WHEEL BEARINGS:** correct adjustment. No vertical movement.
- [] [] **BRAKES:** minimum 50% pad thickness. 914 check inner rear pads. No cuts or abrasions in lines; no cracks in drilled or slotted rotors.
- [] [] **WHEELS:** no cracks or bends; tight lug nuts & valve caps.
- [] [] **CENTER-LOCK WHEELS** (if applicable): Center-lock nuts torqued to factory specification and locking mechanism fully engaged.
- [] [] **TIRES:** no cracks; good condition; min 3/32" tread (except high performance tires); front tires same size; rear tires same size; no rubbing on fender lips. All tires same type. Street tires no more than 5 years old, Slicks/R-comp no more than 3 years old.
- [] [] **LEAKS:** no fluid leaks (oil, gas, brake, coolant). fuel pump & fuel lines on 914.
- [] [] **EXHAUST:** securely fastened, no leaks.
- [] [] **REAR SUSPENSION:** no excessive play in suspension; half shaft bolts, sway bar & shock bolts.
- [] [] **RUST:** no excessive rust.
- [] [] **DOORS:** check all doors, MUST be operable from inside and outside.
