[] PCA NATIONAL REQUIRES THAT ALL CARS equipped with a 5-, 6-, or 7-point harness MUST have appropriate aftermarket seats OR Porsche GT Carbon (LWB) seats OR other manufacturer seats designed for use with multi-point harnesses in the car in which they are installed. Cars MUST have equal restraints installed for driver and instructor or other approved passenger. Harness webbing must not be older than five years.

[] **A FUNCTIONAL FRONT TOW HOOK MUST BE AVAILABLE FOR ATTACHMENT PRIOR TO TRACKSIDE INSPECTION.** Drivers must ensure that at least one functional tow hook is correctly attached to the car prior to trackside inspection.

[] Assigned numbers at least 4" high must be legibly placed on both sides of the car and the rear, without obstructing outward vision.

PASS FAIL PRE-EVENT TECH INSPECTION LIST

- [] [] **BRAKE LIGHTS:** lights must be functional
- [] [] **GLASS:** No cracks in windshield, windows, rear glass; plastic/polycarbonate structurally sound; rubber gaskets secure.
- [] [] **MIRRORS:** at least one securely mounted, unobstructed, functional rear-view mirror.
- [] [] **PEDALS:** free return, in good operating condition; firm brake pedal.
- [] [] **BATTERY:** securely fastened, electrically isolated, no acid leaks or corrosion.
- [] [] **BATTERY CAPACITY:** **THIS VEHICLE DOES NOT CONTAIN A BATTERY WITH GREATER THAN 29 KWH CAPACITY.**
- [] [] **BELTS:** fan and accessory belt(s) tight, secure, and in good condition.
- [] [] **TROTTLE RETURN:** freely operating and with good springs/motion; check both springs on CIS cars.
- [] [] **BRAKE FLUID:** sufficient fluid (DOT 3 or 4 recommended), should be bled prior to each track event, **MUST** have been changed within last 12 months. **Date of last Brake Fluid Change:** _____
- [] [] **FRONT SUSPENSION:** no excessive play in steering or suspension; lower trailing arm to radius arm tight; axle and shock bolts tight; no damper or steering fluid leaks; ball joints in good condition; tie rods secure; axle boots and seals in good condition with no excessive leaking; sway bar bolts and mounts and end links secure and in good condition; 356 steering box – tight cover and coupling, no cracks; 900 series – tight steering rack.
- [] [] **REAR SUSPENSION:** no excessive play in suspension; no leaks; half shaft bolts, shock bolts, sway bar bolts and mounts, and end-links secure and in good condition.
- [] [] **WHEEL BEARINGS:** correct adjustment; no vertical movement.
- [] [] **BRAKES:** minimum 50% pad thickness; no cuts or abrasions to brake lines; no cracks in drilled, slotted, or solid rotors; car should have track appropriate pads; **STREET PADS MAY NOT LAST A DAY ON TRACK.**
- [] [] **WHEELS:** no cracks, bends, warping; correctly torqued lug nuts/bolts; tightened valve stems.
- [] [] **CENTER LOCK WHEELS:** (if applicable) Center-Locks torqued to factory specification; locking mechanism fully engaged.
- [] [] **TIRES:** no cracks, good condition; appropriate tread depth for tire/car to use on track; front tires same size and specification; rear tires same size and specification; no rubbing on fender lips;
STREET TIRES no more than 5 years old, SLICKS / R-COMPS no more than 3 years old.
- [] [] **LEAKS:** no fluid leaks (oil, fuel, brake fluid, coolant).
- [] [] **EXHAUST:** securely fastened; no leaks.
- [] [] **RUST and INTEGRITY:** no excessive rust; no structural damage.
- [] [] **DOORS:** check all doors, **MUST** be operable from inside and outside; non-fixed windows must lower fully.

- [] [] **ROLL BAR:** required on all open cars without factory roll-over protection or hard top; check correctly installed.
- [] [] **SEATS:** Must be part of equal restraint system on both sides of car if more than one seat is present.
- [] [] **SEAT BELTS:** must be part of equal restraint system on both sides of car if more than one seat is present; metal to metal belts securely anchored; no fraying, rips, tears or damaged seams;
