NECC is proud to bring you a day of high-performance driving at New York Safety Track.

The Event:

Our high-performance driving event consists of tech inspection, group driving sessions and open-track driving sessions throughout the day. Timed laps begin mid-afternoon. No transponders necessary; we'll be using a stop watch timing system with two timers on each car.

All makes and models of cars are welcome to participate in this event including unmodified factory street cars as well as cars modified for track use. Our starting grid often includes Porsches, Mazdas, Mustangs, Corvettes, Camaros, Mini Coopers, Corvairs and more. We have had everything from a Ferrari to a Yugo on the track with us. No matter what you drive, you will get plenty of time on the track.

All cars and drivers will be subject to our usual safety and tech inspection procedures outlined below. 3-point or greater safety harnesses are required. Roll bars required for convertibles. All drivers at all times when on the course must wear safety helmets. Helmets must have a Snell Foundation rating of either M2015, SA2015, M2020 or SA2020.

Planning Your Day

- Registration:
 - a. Register online at ClubRegistration.NET. Here is their web address: https://clubregistration.net/events/event-details.cfm?event_id=14387
 - b. Register on or before May 18 to receive the discounted track-day registration price of \$325 per driver. After that, the price rises to \$375.
 - c. Want more savings? Check out our NYST / Pocono combo deal at: https://clubregistration.net/events/event-details.cfm?event_id=14389

Payment:

- a. When you register for one of our track day events, ClubRegistration.Net will prompt you to pay the registration fee using your credit card. Please do so.
- b. As a last resort, you can pay when you enter the track premises on the morning of the event, but pre-payment through ClubRegistration.NET is highly preferred.

Lodging:

- a. Make your hotel reservation.
- b. Refer to the Recommended Hotel section below.
- 4. Forms: Print and complete these two forms.
 - a. Driver Information Document a copy is provided below,
 - b. Technical Inspection form a copy is provided below.

Bring both – the Driver Information Document and the Tech Inspection Form - to the track.

5. Car Number:

- a. Approximately one week prior to the event, we will send an email to you with the car number we have selected for you.
- b. Generally, it will be the same as the one you specified when you registered. However, when two or more drivers pick the same number, we will need to alter the number for one of them.

Arrival:

- a. Park your track car in any of the spots in the upper or lower paddock areas.
- b. Check-in at the NECC registration table located in the pole building located at the top of the hill. Pay if you haven't already done so.
- c. Have your car number on upper right corner of windshield and on both sides of the car. Magnetic, tape or shoe polish numbers are acceptable.
- d. Present your car, Driver Information Document and Tech Inspection form to the NECC tech inspector when you park in the field where the paddock is located.
- e. Attend the mandatory drivers meeting. There, you will receive a wrist band that will serve as evidence that you've met the prerequisites for driving on the course.
- f. Drivers who have registered for the Driving Instruction Session need to attend the special meeting that will be held for them. See the Schedule below for times.

Corner Work

New York Safety Track will provide the corner workers. Drivers will not be called upon to perform this task.

Locating the Track.

GPS Coordinates: 42.4867, -74.7807. Depending on the service, the town may come up as Davenport, Harpersfield, or Jefferson.

Entering the Track Premises.

The main gate is generally open from 7:00 AM – 10:00 PM daily. When you first enter the premises, the track staff will require you to sign a waiver and release document. Please be prepared to accept the terms and conditions of that document.

Fuel. Air.

Neither fuel nor air are available for sale at New York Safety Track, so be sure to tank-up before you arrive!

Food and Drink.

NYST has a canteen that serves breakfast and lunch. It is usually open for NECC events. If not, food is available at locations within twenty minutes of the track.

Noise Control.

The following paragraph is copied from the Car Rules document posted on the NYST website. It applies to our event:

Sound levels will be monitored. Vehicles found to be over the limit will be asked to correct on the first offense, then not permitted to participate on subsequent offenses.

Recommended Hotels

For those who need lodging, we recommend the Super 8 at Oneonta / Cooperstown, located at 4973 State Highway 23, Oneonta, New York 13820-9802. (A straight run of about 22 minutes to the track.) You can make reservations by calling their front desk at 1-607-353-6875.

We also recommend the Super 8 at Cobleskill, located at 955 East Main Street, Cobleskill, New York 12043. However, the distance to the track is longer. (A 40-45 minute drive over the mountains to the track.) Their phone number is 1-518-254-6994.

The Super 8 chain is now owned by Wyndham and you can use Wyndham's online reservation system to book your room. This link will take you there. https://www.wyndhamhotels.com/super-8

The NYST website also recommends a number of hotels. If you are trailering your vehicle, be sure to ask about parking space for your rig.

Bringing Your Car on a Trailer?

If you plan to stay overnight, make sure the hotel you choose has sufficient parking space for your trailer.

Note: Driver Instruction Group, (for those who have signed up in advance.) Before our 8:00 AM meeting, have your car inspected and ready to go on the track. We will break for the All Drivers Meeting at 8:30, and then reconvene till 9:15. For the 1st Sessions, we will go out together in Group C. Line up behind the instructor's car on the starting grid. Terry Stafford will be your instructor.

Rules for You and Your Car

NECC Rule Book.

NECC has comprehensive rules for cars and drivers who engage in high-speed events. They are posted at our website at:

NECC rules will be strictly enforced for cars and drivers.

NECC Tech Inspection.

Failure to pass tech inspection will result in your car being disallowed from being driven on the course.

A sample copy of the NECC Tech Inspection form is included among the attachments to this document as a courtesy. You will receive an official copy of the NECC tech inspection form when we receive your payment. The official copy serves as proof of payment.

Before you leave home, please inspect your car using the official copy and make any necessary adjustments or repairs. Then, when you arrive at track, present your car and the official copy of the tech form to the NECC Tech Inspector, who will re-inspect your car on the spot.

If your car fails tech inspection, you may be due a <u>PARTIAL</u> refund of your registration fee depending on the circumstances. Check our Refund Policy at

Reminders.

LAP AND SHOULDER BELTS: All vehicles must be equipped with lap and shoulder belts for the driver. Additionally, every Competition-type vehicle must have a minimum of a 4-point harness with 3 inch webbing. Competition-type vehicles are defined in the NECC Rule Book.

ROLL BARS REQUIRED FOR OPEN CARS: Any convertible or roadster must be equipped with a roll bar or roll cage. See:

DRIVER HELMET: All drivers at all times when on the course must wear safety helmets. Helmets must have a Snell Foundation rating of either M2015, SA2015, M2020 or SA2020. The rating is printed on a sticker located underneath the padding.

DRIVER INFORMATION DOCUMENT

PLEASE READ AND UNDERSTAND THE FOLLOWING RULES AND INSTRUCTIONS. .

SAFETY. Safety is our prime concern. <u>We will have participants with different cars, speed and experience</u>. Please be conscious of this and courteous to others. Remember, this is PRACTICE-NOT RACING. Have fun.

PRINT, READ & SIGN. Print, read, sign and submit this document at the NECC table located in the NYST pole building.

TECH INSPECTION. Tech forms will be completed and signed by car owner and placed on windshield.

- 1. Driver will be in driver's seat with helmet present but not worn at time of inspection.
- 2. Inspector will have driver show the Snell date rating of the helmet being used, (Snell 2015 or newer), and also apply the brakes to verify that the brake lights are functional.
- 3. Inspector will not touch vehicle or helmet. If brake lights are functional and the helmet conforms to specifications, inspector will sign the inspection form, place it back on the windshield, and attach an inspection sticker to the top of the driver's side windshield.
- 4. <u>For High Performance Driving:</u> Long sleeve shirt and long pants (cotton blend minimum), wrist band, all loose items out of car. Helmets must have a Snell Foundation rating of either M2015, SA2015, M2020 or SA2020.
- 5. Driver will take inspection form and the signed driver information sheet to the NECC table at the track, turn both forms in, and receive a wristband. Both inspection sticker on the car and wristband on the driver must be present for entrance on the track.

GROUP ASSIGNMENTS & CAR NUMBERING. We will inform you of your Group assignments when you check-in. Have your car number on upper right corner of windshield and on both sides of the car. Magnetic, tape or shoe polish numbers are acceptable.

FLAGS

RED- Safely stop where you are and pull off track. Do not move. STANDING YELLOW- Slow down and be alert. NO PASSING!

WAVING YELLOW- Problem ahead. Use extreme caution.

GREEN- Track is clear. Hammer it!

STANDING BLACK- Track is closed.

POINTED BLACK- Come in. A problem with you or your car.

CHECKERED- Practice session or timed laps are finished.

PRACTICE SESSIONS. The event begins with group sessions following the enclosed schedule. At the end of the group sessions, the track is open. While Group C is on the track, all other participants can start staging for the open session. Whenever you want track time, get in line. Run as long as you want. Obey flags. You may be flagged in to give others a chance to run. If blackflagged you can get back in line.

- DURING GROUP SESSIONS, first few laps will be under yellow to allow familiarization of course. Space yourself out.
- NO PASSING. NO RACING.
- No passengers/instructors at any time without pit marshal approval.
- Obey flags. Acknowledge flags by waving at ALL Corner workers during warm up session.
- Second black flag for violations means go home.
- Move off line prior to coming into pits.
- If two (or more) wheels come off course-come in. Stop for check on pit road. No other stopping allowed on pit road.

OPEN TRACK. Same rules apply except:

- Passing allowed but ONLY ON THE MAIN STRAIGHT.
- It is the responsibility of the car doing passing to move off line and finish the pass BEFORE entry into the corner.
- DO NOT RACE OTHER DRIVERS INTO THE CORNER. NO LATE PASSING.
- Cars being passed must hold their line while being passed.

TIMED LAPS PROCEDURES. There is no particular order in which timed runs are conducted. At the start of timed runs, line up on pit road. Leave enough room in front of your car so that you can be pulled out of line because we often pair up cars based on demonstrated speed. Your first lap before you take the green flag is the warm-up lap. After you take the green flag continue to drive until you see the checkered flag. If for some reason our timing personnel have missed one of your laps or are not satisfied, you will be given an extra lap. Do not confuse the issue by counting the laps yourself. When you receive the checkered flag take one more lap at a slightly reduced speed and enter the pits before you cross the start finish line.

- Entry lap starting from pit road.
- If two drivers share the same car, tell pit marshal what number is running.
- Exit lap. Enter pits. Maintain reasonable speed.
- If you catch a car-don't interfere with his run. Do not pass!
- Do not pull in! We will know and you will be awarded extra laps as needed.
- Continue to do hot laps until you see the checkered flag.
- Do not bother the timing personnel. Times posted as soon as possible.

NECC and its representatives and affiliates are not responsible for the failure of any components or for any incidents related or consequential to such failure. - 1. Competition-Prepared Vehicles must be equipped with (a) 3-point body restraint belts with 2" webbing or better, (b) braced roll bar or cage, (c) fire extinguisher or other fire suppression system, and (d) driver window netting where practicable. A Competition-Prepared Vehicle is one that either (a) was manufactured specifically for racing, such as a formula racing car, or (b) is not street-legal because it lacks equipment or features the law requires to allow one to operate it legally on public roads at any time and without restriction.
- 2. Convertibles must be equipped with roll bar or cage. Factory roll bars generally acceptable.
- 3. See NECC Rulebook for Cars and Drivers for full explanation of clothing requirement
