## Suncoast PCA Region PCA DE MINIMUM STANDARDS: EQUAL RESTRAINTS

Both the driver and passenger MUST HAVE AND USE THE SAME RESTRAINT SYSTEM.

PCA National has modified the minimum standards related to use of head and neck devices or HANS. The modified requirements will impact any driver who has a multi-point harness (5, 6 or 7 point) installed in their car. It DOES NOT apply to drivers who only use the standard 3-point safety belt system.

Starting January 1, 2019, people driving cars with multi-point harness systems will be required to utilize a head and neck restraint system, commonly referred to as a HANS device. This mean both the driver and passenger must have a head and neck restraint device if the driver is using a multi-point harness.

A head and neck restraint device certified as meeting the standards of either SFI 38.1 or FIA 8858 or its successor is required. The use of such a harness system without roll protection and a head and neck restraint device may result in an unsafe environment and is not a COMPLETE SYSTEM.
