

Border Crossing 2024

Racers bringing your own race car into Canada.

- Use the car or RV lane at the border.
- Have Proof of citizenship or residency
- You may be asked to prove you own the car you are transporting, so you should have proof of ownership of your race car (title, registration, Bill of Sale, log book).

Race Teams and Shops bringing customer cars into Canada.

- Use the Commercial Vehicles/Truck lanes at the border.
- Have Proof of citizenship for each person in the truck
- Have copies of the CBSA bond letter and promoters letter we provide you.

- Because you are considered a commercial carrier, you will need to provide additional documents that a customs broker can help you with. - DO Not Bring Weapons or Drugs, including Marijuana into Canada

FYI

* U.S. citizens must **provide proper identification**, proof of citizenship. A valid U.S. passport. Is preferred. Lawful permanent residents of the United States must show documents for travel to Canada. A valid passport from their country of nationality (or an **equivalent acceptable travel document**) and a valid green card (or equivalent valid proof of status in the United States) are preferred.

“Competition Racing Vehicles”

81. Non-resident participants in closed-course races sanctioned by a recognized racing sanctioning body such as the Fédération Internationale de l'Automobile (FIA), National Association for Stock Car Racing (NASCAR), American Motorcycle Association (AMA), Indy Racing League (IRL), etc., are not required to document or post security for the following goods:

- (a) racing vehicles;
- (b) trailers and conveyances for moving racing vehicles;
- (c) repair parts and repair equipment such as tires, wheels, spare parts for the racing vehicles;
- (d) tools and portable shop equipment required to maintain a racing vehicle; and
- (e) mobile accommodations, mobile kitchens and related equipment, when imported to support the racing team and support personnel and when used to promote race-related activities.

82. These goods qualify for customs duty-free entry under tariff item No. 9993.00.00 and for relief from the GST/HST and excise taxes under the *Non-taxable Imported Goods (GST/HST) Regulations* and Item 38 of the Schedule to the *Temporary Importation (Excise Levies and Additional Duties) Regulations*. It should be noted that fuel in excess of the normal tank capacity of the racing vehicle, oil, grease and other consumables are not eligible for customs duty or GST/HST relief and shall be assessed customs duties and taxes at the time of importation.”

In response to your correspondence dated February 1, 2024, the Canada Border Services Agency (CBSA) - International Events and Convention Services Program (IECSP) officially recognizes the following event:

The information provided to the CBSA states there will be approximately 100 to 200 foreign attendees at each event which are open to the general public.

It should be noted that, non-Canadian exhibitors may import qualifying items temporarily as outlined in the provisions of tariff classification **9993.00.00.00** duty free, on the condition that the goods will be exported from Canada upon the completion of the event.

Please be advised that the following goods qualify for temporary importation under the provisions of Memorandum [D8-1-1](#), *Administration of Temporary Importation (Tariff Item No. 9993.00.00) Regulations* when imported by teams, non-residents or their support personnel:

1. Racing vehicles;

2. Trailers and conveyances for moving racing vehicles;
3. Repair parts and repair equipment such as tires, wheels and spare parts;
4. Tools and portable shop equipment required to maintain a racing vehicle;
5. Mobile accommodations, mobile kitchens and related equipment when imported to support the racing teams or support personnel or to promote race-related activities;
6. Safety vehicles such as first response vehicles and mobile medical units and related equipment for use solely at the racing event;
7. Television production trucks and related equipment to produce segments covering the race event.

Fuel in excess of the normal tank capacity of the racing vehicles, oil, grease, and other consumables are subject to payment of duties and taxes at time of importation into Canada. Listings of goods being imported should be prepared indicating description, quantity and values.

It has been noted you have posted bond number 10030678 and that you have not appointed an "Official Customs Brokers" to assist with customs clearance of goods destined for your event.

Goods imported for sale are not eligible under tariff classification 9993.00.00.00. These goods must be accounted for at time of release on a [Form B3](#), *Canada Customs Coding Form*. Commercial release processing is fully explained in Customs Memorandum [D17-1-5](#).

Under certain circumstances, the CBSA will require a security deposit on goods temporarily imported to Canada. These goods are normally documented on the Temporary Admission Permit ([Form E29B](#)).

At the time of exportation, goods granted temporary admission on a Form E29B or Carnet must be presented along with importer's/owner's copies of the appropriate documentation to the CBSA for verification and certification. This presentation may occur at a CBSA office inland or at the port of export, depending on the circumstances involved and is necessary for you to receive a refund of any securities posted. Please note that the refund is not immediate.

CBSA requires everyone seeking admission into Canada to properly declare themselves to the CBSA by providing accurate identification. CBSA will accept a valid passport as proof of citizenship.

Persons who have been convicted of any criminal offences may be inadmissible to Canada. For more information please visit: www.canada.ca/en/immigration-refugees-citizenship/services/immigrate-canada/inadmissibility.html

If you are an event organizer and you have attendees from visa-requiring countries (www.cic.gc.ca/english/visit/visas.asp), please contact the Special Events Unit of Immigration, Refugees and Citizenship Canada (IRCC) at special.events@cic.gc.ca with the specifics of your event. They will assess the visa requirements of your event.

Visa-exempt foreign nationals, excluding U.S. citizens, now require an Electronic Travel Authorization (eTA) to fly to or transit through Canada. For more information please visit: www.canada.ca/en/immigration-refugees-citizenship/services/visit-canada/eta/apply.html

Foreign nationals may engage in exhibiting, selling or displaying goods without a work permit provided they are not selling to the general public. Direct sales to the general public require a work permit. For more information please visit: www.canada.ca/en/immigration-refugees-citizenship/services/work-canada.html

If you are arriving at one of Canada's main airports (www.cbsa-asfc.gc.ca/services/border-tech-frontiere/pik-bip-eng.html), you can complete your customs and immigration declaration at an airport kiosk or eGate upon arrival.


Save time and submit an Advance Declaration (www.canada.ca/en/border-services-agency/services/arrivecan.html), up to 72 hours before you arrive in Canada. This allows you to do so at your own pace, and in a preferred environment. Special access to express lanes in the arrivals hall will be given to travellers who have used this feature. You may then retrieve your declaration by scanning your travel document and confirming your identity at an airport kiosk or eGate before presenting yourself to a border services officer.

All passengers arriving at other airports must fill out a paper E311 CBSA Declaration Card prior to arrival and present it to a border services officer.

To facilitate border procedures during entry into Canada, each participant should have a copy of this letter and be in possession of an itemized list of articles stating description, quantity and value for presentation to CBSA officials.
